### 15. Multidisciplinary / interdisciplinary

NEP 2020 envisages a holistic and multidisciplinary education that aims all-round development of student's i.e. physical, intellectual, social, emotional, moral and aesthetic development. After the enactment of NEP-2020, the Government of Assam through the Director of Higher Education, Assam, in consultation with the universities has taken steps for implementation of NEP-2020 and CBCS course in Assam.

Habraghat Mahavidyalaya, Krishnai is an affiliated College under Gauhati University. The College has been running CBCS course since 2019 as per instruction of the affiliating University. Since the college is a single stream college i. e. only Arts stream, it cannot be introduce multidisciplinary course with Arts, Science and Commerce. Hence the college has taken some initiatives for all round development of the student with introducing Certificate Course in Computer Application (CCA), Skill Oriented Certificate Course (SOCC) and Value-Added Course (VAC). Besides, there is a compulsory Subject "Environmental Studies" in regular Curriculum in Degree Course which is flexible and innovative. Through this course the students can know about their environment and environmental issues and problems.

The College has introduced many multidisciplinary courses as per guidelines of the affiliating University i.e. Gauhati University from the Academic Session-2023-24 with a view to implement the NEP-2020. Some of the courses are- Foundations of Mathematical Sciences-I and Makers of Modern Assam.

Moreover, various days, ceremonies, festivals and programmes are organized in the college so that the students can go the surrounding areas and to meet the community.

### 16. Academic bank of credits (ABC):

Habraghat Mahavidyalaya, Krishnai has registered Academic Bank of Credit (ABC) of the Students of BA 1st Semester w.e.f. Academic Session-2023-24 and the students have got ABC ID Cards which are approved by the Principal of the College and uploaded in the SAMARTH PORTAL.

### 17. Skill development:

The College has been continuing several skill-oriented Courses for capacity building of the students since 2016-17. The courses are-

1. Certificate Course in Computer Application (CCA),

Habraghat Mahavidyalaya is located in rural areas of Assam and affiliated under Gauhati University. The college runs courses only in Arts Stream and in both Assamese and English Medium. Students of the college are from multi- culture. Rabha, Bodo, Muslim, tea-tribe, Garo, Bengali students are there in the College. Courses are delivered in English and Mother Tongue Assamese. Though there is diversity among the students, the College attempts to create integrity among the students.

The medium of instruction of the college is Assamese and English in UG level and the faculty members try to deliver lectures in bilingual mode. To create integrity among the students, different programmes like games- sports, festivals, cultural procession, literary activities, etc. are organized in the college.

#### **19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

The affiliating University i. e. Gauhati University frames and

publishes the syllabi of all the courses of its affiliated colleges keeping in view the latest knowledge requirements. The syllabi mention the course outcomes. The Programme Outcomes, Course Outcomes and Programme Specific Outcomes are uploaded in the College website.

The College tries its level best to achieve the objectives as prescribed by the University adopting the following mechanisms

1. Semester-wise Orientation Programme is organized at the beginning of every academic session to make the students aware of their courses and evaluation processes which is also available for them in the college prospectus.
2. For attainment of programme out comes as well as learning outcomes the college conducts continuous evaluations based on periodic test, surprise test, oral test, open book test, unit test etc.

#### 20.Distance education/online education:

The College has a study centre of Krishna Kanta Handiquoi State Open University (KKHSOU) which offers U G and P G Courses.

During the Covid-19 Pandemic the College conducted Online Classes regularly. The faculty members are trained to use ICT in teaching. We use Googole Class room, Google Meet, Zoom App etc to teach the students.

The college is situated in sprawling campus of 21 acres of land with buildup area of 6193.8 Square Meter accommodating adequate infrastructure and physical facilities for teaching-learning. There are 12 numbers of classrooms are there for running BA Major and General Course and two Smart Classrooms attached with DigitalInteractive Panel. There is one Psychological Laboratoery with essential equipments. There are 4 (Four) classrooms with ICT facilities for conducting Digital Classes. In addition, there are 3 (Three) Mobile projectors used in other classrooms as and when required. There are all total 88 numbers of computers for the use of teachers, Students and the office stuff. There is one Language lab with 25 (Twenty Five) numbers of computers, 1 (one) Computer lab with 12 numbers of computers and 1 (one) E- Recourse Browsing corner with 21 numbers of computers. There is a Central Library Enriched with 16698 numbers of text books and 845 numbers of reference books. The Library is also equipped with Question Bank Repository, Video Bank, PPT Bank, Publication Repository, OPAC Facility, INFLIBNET, Reprographic as a support facilities for teaching and learning.
